Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school from class I to XII shall be restricted to 28 as per appendix – V, out of which the school can run a maximum number of 08 sections in senior secondary classes i.e. 04 in class XI and 04 in class XII, further, subject to the condition that the school shall not run more than 1/3 of the total sections running in the school at any point at the senior secondary level. The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above.
2	The school is directed to run atleast 01 section each of bal-vatika I, II & III in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
3	The school is directed to pay the salary to its staff as per Central / State Govt. Norms through ECS mode only and submit the documentary evidence of records of 02 months of salary paid to teaching staff as per Govt. norms in compliance within 03 months
4	The school shall conduct training of its teachers with CoE Chennai within 03 months and submit the compliance.
5	The school is directed to ensure that all essential valid documents are available under the head Mandatory Public Disclosure (as per annexure – IX) on school's website at all time and the link of certificates should be remain functional and submit an undertaking in this regard on its letter head duly signed by the principal and manager of the school in the compliance within 03 months.
6	As per the recommendation of NEP, the school shall ensure the participation of its students in the Structured Assessment for Analyzing Learning(SAFAL), an exam conducted by the Board every year. This exam, designed to assess and enhance students' learning, is a valuable initiative for their holistic development, as per the guidelines issued by the Board vide circular no: Acad-49/2024 dated 26 June 2024.

7	The school will ensure the Holistic Progress Card (HPC) is used for the foundational stage according to the guidelines issued by the Board via notification no. CBSE/Director (Acad.-Assessment)/2023 dated 27.12.2023.
8	The school shall submit an undertaking to upload all requisite information regarding students, teachers, and infrastructure details available in the school on the UDISE and OASIS Portals. The registration of the students in classes IX and XI shall be conditional on the school providing complete information on the UDISE and OASIS Portals.
9	The school shall ensure that all teachers undergo at least 50 hours of Continuous Professional Development (CPD) every year, vide notification no. 16/2021 dated 24.09.2023, out of which 25 hours should be from COE Chennai.

Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

Sl. No.	The school is directed to ensure that :
1	The total number of section of the school shall be restricted to 28 as per Appendix- V.
2	All CWSN toilets are not seen in the video. Those which are seen are not as per norms. They are regular cubicles, too small for a wheelchair/walker to navigate. Not clear whether they are accessible as general toilets are on raised platforms. The school shall construct separate toilets for CWSN, boys and girls on every floor which are easily accessible, with permanent signage, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
3	The ramp at the entrance is not seen in the IC video. The school is directed to ensure ramp at the entrance, ramp / lift to access upper floors and submit the compliance within 3 month on SARAS portal.
4	The composite lab is not properly laid out. Looks like a class room instead of lab with work stations and utilities, and requisite safety measures. The school shall upgrade the composite lab as per SoP of the Board within 3 months and submit compliance on SARAS.
5	The library is seen as congested and under sized for the current strength of the students. The school shall shift the library to a bigger room or create separate library for classes 9 to 12 as per SoP of the Board within 3 months and submit compliance on SARAS.
6	The school shall conduct training of its teachers with CoE Chennai within 3 months and submit the compliance.
