

principal objectives of "Sri Jayendra Saraswathi Golden Jubilee Educational Trust":

- 5.1 To establish, maintain and operate schemes for student's education, scholarships and render other types of aids to students including supply of books, stipends, grants and other incentives to study, without any distinction to caste, colour, race, creed, or sex.
- 5.2 To establish training centers, integrated Veda Patasalas, allied education institutions like schools, colleges, technical institutions, Medical Schools all for the benefit of students, youth, men and women to enhance their skills and knowledge.
- 5.3 To render financial help, material help and medical help, etc., to
  - a) The poor and needy students studying in recognized schools and colleges.
  - b) Any deserving person(s) irrespective of caste, creed, sex and religion of the organization(s) involved in social service activities, which the trust may identify from time to time, and
- 5.4 To open and run educational and training institutions including pre-schools, schools and colleges to serve the needs of the under privileged and poor students.
- 5.5 To engage teachers, instructions and experts for good knowledge and moral characters to achieve the objectives.
- 5.6 To construct, establish and run boarding residential accommodation for students and those connected with the institution.
- 5.7 To grant scholarship and loans for poor and deserving students to continue their education.
- 5.8 To organize tours, exhibitions and cultural programmes for the welfare of the students.

- 5.9 To organize seminars, talks and camps of similar nature to develop the thoughts and to encourage participation of the community.
- 5.10 To promote, support or to grant aid to institutions for the promotion of science, literature, music, drama and fine arts for the preservation of Indian Culture, that the benefits of the Trust are open to all irrespective of the caste, religion, sex, etc.
- 5.11 To spread use of technology among under privileged youth and adults to improve the quality of their life.
- 5.12 To establish research and training centres for the furtherance of education / learning in its various fields and branches.
- 5.13 To undertake propaganda, training and education of the masses either of its own or in co-operation with similar Agencies working for the cause of all round development of the Society.
- 5.14 To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- 5.15 To function as a Non-communal Trust and as secular organization.
- 5.16 To confer title on eminent personality in the field of science, education, literature, etc.
- 5.17 To establish the colleges to impart education in the area of higher education especially the emerging field like, Electronics, Bio-technology, and other allied fields.
- 5.18 To accept / give donations in cash or kind, takeover and run any institutions on lease or any other terms without prejudice to the above mentioned objects of the Trust.
6. AND GENERALLY to do in all public charitable purposes for public benefit without any discrimination of Caste, Color, Gender, Religion, Faith, Race or any Nationality.

**7. THE BOARD OF TRUSTEES SHALL HAVE THE FOLLOWING POWERS:**

- 7.1 To manage the properties, assets and funds of the Trust, from time to time, such regulations (not being inconsistent with this deed) as they may think fit for and necessary for the purposes of such management and control or in connection with the execution of any of the subject herein contained or powers hereby vested in them and may rescind or alter any such regulation.
- 7.2 To accept / give donations, contributions, grants, subscription in cash or in kind from / to any person, company, firm, association, organizations, government, non government or semi government agencies, national or foreign funding agencies, family Trust, or corporate bodies for furtherance and achievement of the objectives of the Trust.
- 7.3 To review the affairs of the Trust and a necessary.
- 7.4 To appoint officers and members of staff for the Trust and to prescribe their condition of service.
- 7.5 To open and to provide for operating banking accounts.
- 7.6 To raise loans with or without security or to invite donation and financial help.
- 7.7 To authorize person (s) to sign or execute documents on behalf of the Trust.
- 7.8 To grant receipts for aid or donation received.
- 7.9 To acquire land or building on the lease or way of purchase in future.
- 7.10 To sell or give on rent / lease or on hire any immovable or movable property of the Trust for some certain period (s) on

such terms and conditions as the Trustees may think fit and proper from time to time.

- 7.11 To open any type of bank account (s) whether saving account, current account, fixed or otherwise, in the name of the Trust or institution(s) or programme (s) run by the Trust with any scheduled banks (s) or post office (s) and to operate by the authorized signatory or signatories as Board of Trustees shall think fit and proper to authorize any person or persons, unless and until determined otherwise the such bank account(s) shall be opened and operate jointly with signatures of any two members of Board of Trustees.
- 7.12 To give guarantee of the assets and property of the Trust, including the bank guarantee on behalf of the Trust to corporate bodies, person, firms, institutions, as Trustees may decide from time to time. The Trustees shall not be personally liable for such guarantees or the securities.
- 7.13 To gift, lease, and transfer the immovable and movable properties of the Trust that may be acquired in future.
- 7.14 To appoint new member or members of Board of Trustees by a resolution and to remove any of the Trustee, who become bankrupt or acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee, by resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.
- 7.15 To appoint from time to time on such terms and conditions as they may determine a Secretary, Manager, Executive Director, Director(s) and other officer(s) or member(s) of staff for carrying out the activities of the Trust and to remove at any time any

such Secretary, Manager Executive Director, Director(s) and other officer(s) members(s) of staff.

7.16 The Trustees shall invest the Trust fund in government securities, saving certificates, fixed deposits or in any other form of investment authorized under provisions of INDIAN TRUST ACT and INDIAN INCOME TAX ACT, 1961, as they shall deem expedient.

7.17 In case of occurrence of any vacancy amongst the Trustees because of death, resignation or incapacity of any Trustee or any other cause, a new Trustee may be appointed to fill the Vacancy.

8. **NO BENEFIT TO TRUSTEES**

All the incomes, earnings, movable / immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and object only as set forth in the Memorandum of the trust and no profit, thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any other manner whatsoever to the present or past members of the trust or to any person claiming through any one or more of the present or the past members.

No member of the trust shall have any personal claim on movable or immovable properties of the trust or make any profits, whatsoever due of his membership.

9. **ACCOUNTS**

The financial year for the Trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March and the accounts of Trust or institution (s) or programme (s) run by the Trust shall be audited yearly by the auditors b(s) or chartered accountant or a firm of chartered accountants to be appointed by the Board of Trustees and the fee for auditor(s), if paid, shall be a part of outgoing amounts from the Trust Funds.

10. **AMENDMENT CLAUSE**

If the object or any of the powers or any provision in the Trust Deed is inconsistent with the requirements of the law relating to Public Trusts or Trusts eligible for exemption under the Income Tax Act, or any other direct tax law, such object, power or provisions will be modified to the extent that they should accord with such law so as to continue to be eligible to be treated as a Public Charitable Trust.

11. **RESOLVING DISPUTES**

The trustees are empowered to appoint lawyer, pleaders, advocates to file and defend suit or suits filed for and against the Trust and or in the name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed such application, petition documents for such proceedings and delegate powers to the officers(s), employee(s), staff(s) and Trustee(s) for such proceedings(s) as required from time to time. Further the trustees are entitled to compromise, compound or refer to Arbitration all actions, proceedings and disputes relating to Trust property or properties. It is hereby declared that in the implementation of the objects of the Trust or of the conditions of the Trust the decision of the Trustees shall be final and cannot be called in question by any person whatsoever. All matters not provided for in this Trust deed but necessary for the administration of the Trust of for giving effect to the objectives of the

Trust may be resolution(s) made by the Board of Trustees carried by a special majority of two third of total number of the Trustees.

12. **DISSOLUTION**

It is hereby decided that as and when the Trust is enclosed or dissolved all the funds of the Trust shall be transferred to the other recognized Public Charitable Trust having similar objectives.






As on date there is no movable or immovable property in the name of Trust except corpus fund of Rs.1,000/- mentioned in the Trust Deed.
